Natural Horseman Saddles' TRIAL TO RIDE program:

We are thrilled to be able to provide you with an opportunity to take a test ride in one of our saddles! We look forward to hearing your personal assessment of the comfort and performance results from your rider perspective as well as that of your horse.

You, the customer, will pay for shipping roundtrip of the saddle which will include insurance for the value of the saddle. If you choose to purchase a Parelli saddle, the trial-ride shipping charges equivalent to costs of shipping within the Continental US will be deducted from your purchase.

Be sure to acquaint your horse with Savvy on line first, before climbing on board the saddle. The feeling of having so much room to move will be a new one for your horse, and he/she may experiment with being able to use his back and shoulders. We recommend you view the Parelli Saddling DVD to familiarize yourself with the methodology before saddling your horse. We further ask that you acquaint your horse to the saddle with a Smart Pad™ and shims. If you would prefer a Theraflex pad, please be sure to clarify that in your notes to us.

We expect the saddle to be returned 5 days after receipt, which should allow for weather challenges. If you should choose to purchase a Parelli saddle, please fill out, sign and fax in the order form to the Natural Horseman Saddles' office. (970-403-1374)
